NB-1 A Proposal for Child Care Collaboration in the North End of Haida Gwaii

These models were based on the data from the survey, the working group and previous daycares. These models listed space requirements but did not attempt to calculate capital costs due to the variability of potential models depending on partner organizations. Council agreed that discussions with potential partner organizations is the next step.
