CALL TO ORDER

The Village of Masset acknowledges the un-ceded traditional territory of the Haida Nation on which this meeting is held.

The meeting was called to order at 7:00 pm.

OPENING REMARKS

Mayor Pages read a statement of purpose for the public meeting regarding the application by S.A.M. Productions Ltd to establish a non-medical cannabis retail store in Masset. All participants were assured that they would have an opportunity to make a presentation about the application only and were asked to clearly state their name and address before commencing their remarks. Mayor Pages also indicated that Council members were there to listen to concerns only, not debate the issue nor make a decision at this time.

APPLICANT PRESENTATION

Mayor Pages opened the floor to the presentation by Mr. Steve Marshall of S.A.M. Productions Ltd (see attached documentation).

Councillor Johnston asked the applicant if all products that would be sold were government regulated. Mr. Marshall indicated that all products sold will be regulated and are received in the appropriate packaging.

Councillor Carty asked Mr. Marshall to clarify why his establishment is termed "non-medical" as it will sell CBD oils. Mr. Marshall explained that a medical practitioner will not be on the premises to administer particular doses of THC for medical conditions.

I am fully supportive of a tasteful cannabis retail store in Masset. Evidence shows that properly distributed cannabis decreases illegal sales, promotes increased safety of cannabis products by limiting its sale to minors, and cannabis can provide highly sought-after medicinal effects to community members with chronic pain, cancer, etc. Furthermore, the use of cannabis is considered by many to be a means of harm reduction, as its effects are less physically and socially harmful than alcohol or other hard drugs. As long as the business is reputable, I see no problem with such a store.
