1. Shirley Kircheldorf Update Virtual Harbour Days

2. Alec Tsang – BC Hydro Public EV Infrastructure Program

Installation would begin in the spring of 2022. The next step for the Village of Masset would be to sign an MOU with BC Hydro.

Emergency Shelter Housing

The CAO reached out to the Village of Old Masset's administrator, Patricia Moore, and to UBCM regarding the application that was submitted by Old Masset Village Council (OMVC) for the Emergency Shelter project. Based on these discussions, in order to have this project be considered for funding, requires the Village of Masset submitting the application to UBCM's Strengthening Communities' Services program. The current application requires revision and submission by May 14th. The role of the Village of Masset would be to manage the grant as OMVC would be responsible for the actual implementation of the initiative.

Moved by Councillor Williams, seconded by Councillor Carty, that the Village of Masset supports a partnership with the Old Masset Village Council for the Emergency Shelter Housing project; and

THAT a revised application be submitted to the Strengthening Communities' Services program; and

THAT the Village of Masset be responsible for management of the Strengthening Communities' Services grant while Old Masset will undertake the implementation of the Emergency Shelter Housing project.

The CAO updated Council on some of the projects that are underway. The solar project is progressing - waiting for a response from Transport Canada that will help determine next steps in the project. The filter issues with the Water Plant are being addressed. The CFO informed Council that taxes will be mailed by the end of next week.

Mayor Pages attended a meeting hosted by the Honourable Josie Osborne Minister of Municipal Affairs. Connectivity issues were discussed. Mayor Pages thanked the Minister for funding Citywest.
