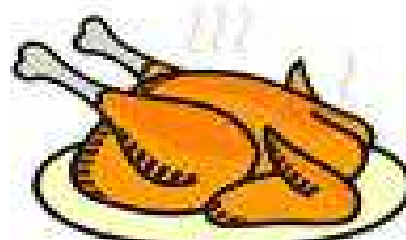


BC PROPERTY ASSESSMENT NOTICES

2012 TURKEY REPORT

The Village of Masset would like to thank the Gwaii Trust for the 2012 Christmas allocation of which we used our portion to distribute turkeys to households as in the past few years. The office staff played Santa for a week handing out 375 turkeys and extending holiday greetings to everyone that came in.

Some people have asked why they need to register, if we are giving turkeys to every household. Registration helps to make the process more efficient and manageable for the staff while ensuring that the benefit of this funding reaches as many people as possible. Registration allows us to know how many turkeys to order to avoid missing people or having turkeys left over. It also makes the distribution process faster as we don't have room to store over 300 turkeys. The registration list is used to keep track of who has collected their turkey and who has not, and contact people if necessary. The turkey hand out seems to be the best way to

distribute this benefit amongst the community as everyone appreciated receiving their turkeys.

Thank you to everyone for making this process as smooth as possible for 2012 and look for the registration notice again in November 2013.
