The Masset RCMP detachment is down to four members with three transferring in, one of whom is a Corporal. One will transfer in December of 2020 and two expected in January of 2021. Sgt. Smith will be transferring out of Masset in March of 2021. There are no new leads regarding the local missing persons case, officers have been spending time chasing down false leads and dispelling rumors that arise on Facebook. A reward is offered and may be increased.

There has been no movement regarding unlicensed vehicles and they are looking into the possibility of ticketing.

A local business has been fined for hosting an event not compliant with provincial health orders
